

.EDU.AU DOMAIN: WARRANTY FOR THIRD LEVEL DOMAIN

Instructions

- The following form is to be completed to meet the **allocation criteria** for a third (or national) level domain name under Schedule A, Sections 2.8 (3) and 2.9 of the .au Domain Administration Rules: Licensing where the general **eligibility criteria** has already been met.

Applicants that are not registered or accredited with a government education or training authority should instead complete [this form](#) covering both the eligibility and allocation criteria.

- The "warranty by the applicant" section of this form must be completed by an authorised representative of the applicant and printed on the letterhead of the applicant or accompanied by photo id of the representative.
- The "warranty by the referee" section of this form must be completed by one of the referees nominated by the applicant and printed on the letterhead of the referee's organisation or accompanied by photo id of the referee.
- The referees must be authorised representatives of current .edu.au licence-holders.
(this includes domains registered at any level in the .edu.au space – e.g. .edu.au, .nsw.edu.au, .vic.edu.au)
- The referees must be from two different entities that are not related entities to the applicant
(related entity as defined by the Corporations Act 2001, section 9 – e.g. not a parent company or subsidiary)
- Please send the completed pages to Education Services Australia via email to registrar@esa.edu.au.
- Upon receipt, your application(s) will be raised for review and processed. Notification of whether the application has been approved or rejected will then be sent to the email address provided as the account contact

Please Note

The registrant or account holder for a referee's domain may be contacted to confirm they are an authorised representative.

In order to meet the allocation criteria for a third level domain name the applicant must demonstrate that they or a project or program their application relates to has national interests and responsibilities either via operating in more than one state or territory in Australia or by other means.

International delivery of education services does not qualify as a national interest or responsibility.

All domain name licences are issued subject to the terms and conditions under the edu.au Registrant Agreement, the published policies and licensing rules. Non-compliance or where found to be in breach of this warranty may result in the cancellation of a domain name licence. Please see www.domainname.edu.au/policy.htm for full details.

Terminology

- Applicant: The legal entity put forward as the registrant for the proposed domain name(s)
- Licence-holder: The legal entity currently listed as the registrant for a domain name in the registry database

- Domain level: Third level domain names are registered at a national level (i.e. <thirdlevel>.edu.au)
Fourth level domain names are registered at a jurisdiction level (i.e. <fourthlevel>.vic.edu.au)
